



Curves has built its reputable foundation on strengthening women, by teaching them healthy eating habits, proper exercise and healthy weight management. KSN, KODE, fourstateshomepage.com, and Curves would like to encourage all contestants to refrain from using prescription/over the counter diet aids. This however, does not include the use of any of the Curves supplement line or over the counter vitamins or protein supplementations. All contestants are welcome to participate in a 6 (six) week solutions weight loss class. The price for this class is at the clubs discretion. Please note that not all clubs offer this class, please check with your local club for more details.

HOW TO REGISTER

Visit a participating Curves facility; weigh-in, then complete and sign the registration form. **YOU MUST REGISTER IN PERSON AT A PARTICIPATING CURVES FACILITY**, no online entries will be accepted.

If your local Curves are not a current participating facility, please encourage the owner/manager to contact KSN/KODE at (417) 781-2345.

WHO IS ELIGIBLE:

Any Curves member, current or any new member who joins a participating Curves during the contest. All contestants must be 18 years of age or older. However, Curves does accept members who are 13-17 years of age. 10-12 year olds can join with special permission from Curves manager/owner.

Employees and their immediate families of Nexstar Broadcasting or a participating Curves facility are not eligible to win.

Contestants must be a member of a participating Curves facility.

RULES:

1. All contestants are required to weigh in at the time of registration. This must be done prior to starting the competition. All weigh-ins must occur at the contestants' home club.
2. All contestants must remove shoes, jackets and items of content from said person prior to each weigh in.
 - a. It is recommended that each contestant wear the same or similar clothing at each weigh in.
 - b. It is recommended that each contestant weigh in one time per week.
 - c. Weekly weigh in results will be reported to KSN/KODE and fourstateshomepage.com. Results will be posted on fourstateshomepage.com. A weekly weigh-in is not required but recommended for each facility and contestant to track progress.

3. Any said member or Curves employee/owner that reports or falsifies weight loss will be immediately disqualified from the contest. Falsifying any weight loss may result in legal action. In the event that the winner is found guilty of falsifying information reported, all prizes received will be revoked.
 - a. In the event of a tie all prizes will be split equally between winners.
4. Winner will be based on percentage of weight loss from the time of registration to the commencement of contest. Final weigh in is to be completed by 6 pm July 1, 2008. Curves will be using the method of the 2 (two) point decimal system to determine weight loss (i.e. 5.35%).
5. The Winner will be announced on July 14, 2008.
6. The Winner will be required to appear on KSN and/or KODE's morning shows and other requested appearances. The winner's name, picture and statistics will appear on fourstateshomepage.com.
7. All contestants' name, picture and statistics can be used for advertising purposes by Curves, KSN, KODE and fourstateshomepage.com
8. KSN, KODE and fourstateshomepage.com shall be held harmless for any inaccurate reporting from participating Curves.
9. Curves International, Curves owners or employees shall be held harmless for mechanical inaccuracies in equipment used for the weighing of contestants. (i.e. there may be a variance between scales at participating locations. This is why it is required to weigh in at the contestants' home club.)
10. At the completion of the "Love My Curves" contest no contestant or club owner/employee can dispute the results. All results are final.
